

Get assurance of whether a procedure has been cancelled

At Udbud.dk you see this description:

EU-procurement procedures are cancelled in the "Contract award notice" section V.1 "Information on non-award".

This notice is not attached to the specific procedure on Udbud.dk, but can on Udbud.dk be accessed through the link to the TED database under the "detailed description of procurement". You should through the link to the TED database frequently check, whether a procedure has been cancelled. This can be done by going through the documents in the document family.

Below in the "detailed description of procurement" is an example of a procedure with more than one contract notice. In this case notice number 2016/S 115-204163 and 2016/S 084-147782.

To verify if one of the contract notices has been cancelled, press the link to the TED database.
